I further agree in warrant that if at any time I believe conditions to be unsafe, I will immediately notify the nearest official and discontinue my child further participation in the activity.
- 2.) I fully understand that: participating at the BV Fishing Derby is "fishing at your own risk". All anglers are fully responsible for their own personal property and I fully accept and assume all such risks that all responsibilities for losses, cost in damages my child incurs as a result of participating in this event. All State laws apply.
- 3.) I hereby release, discharge, and hold harmless the Fin and Feather Sports, the Blackstone Valley Chamber of Commerce, and or coordinators, event Directors, instructors, trainers, members, volunteers, sponsors, the other participants and if applicable, owners in leasers, the town of Hopedale, of equipment used in where the activities take place, (each considers one of the "releases" here in) from all liabilities, claims, demands, losses, injuries, damage to negligence of the releasees or otherwise, including negligence rescue operations; and I further agree that if, despite this release and waiver of liability, Assumption of risk, and indemnity agreement I, or anyone on my behalf, makes a claim against any of the releasee's, I will indemnify, save, and hold harmless each of the release's from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as the result of such claim.
